EVERY EFFORT WILL BE MADE TO PLACE EACH VENDOR IN A GOOD LOCATION. IF POSSIBLE EACH VENDOR WILL BE ASSIGNED THE SPACE THAT HE OR SHE REQUESTED. IN ORDER TO BE FAIR, THE FOLLOWING STEPS WILL BE

- 1) EACH APPLICATION WILL BE DATED AND STAMPED BY THE CHAMBER STAFF WHEN RECEIVED.
- 2) THE APPLICATION WILL BE CONSIDERED COMPLETE ON THE DATE THAT BOTH THE COMPLETED SIGNED APPLICATION FORM AND PAYMENT HAVE BEEN RECEIVED BY THE
- 3) VENDORS FROM PREVIOUS YEARS WILL HAVE PRIORITY BEFORE OTHERS ARE CONSIDERED.
- 4) A PUBLIC NON-PAYING VENDOR WILL NOT BE ASSIGNED BOOTH SPACE ON A PRIORITY BASIS.
- 5) AS MUCH AS POSSIBLE VENDORS SELLING THE SAME OR SIMILAR PRODUCTS (OTHER THAN FOOD VENDORS) WILL NOT BE PLACED ADJACENT TO EACH OTHER.
- 6) NO VENDOR WILL BE GRANTED THE RIGHT TO BE THE ONLY VENDOR OF A PARTICULAR CRAFT OR SKILL.
